Town Managers Report-Mark reported that when the weather improves the office activity and demand for services is dramatically increased. We have been doing our best regarding fiber to the home service to inform people about how to presubscribe and what that means. Fayette roads have not suffered road damage like Jay and surrounding towns from the recent storm events. However the cumulative impact is delaying our reclaim/paving plans for Bamford Hill, Fayette Corner and Sandy River Roads. Spencer paving is a month and a half to two months behind schedule. Sorry to say but we cannot have cold mix base paving in mid-October as it needs to be done no later than end of August mid-September at the latest. We will be buying cold mix to be laid down by our crew and paver just to get us through the winter. But that is what we were facing. Mark reviewed the content of the Board packet efficiency Maine letter re: heat pumps, Road Foreman report that highlighted repair and diagnosis of the excavator and new 2023 International Truck both required to be serviced in the Bangor area. Mark stated Jessica Leighton represented the Town at the Household Hazardous Waste event that was a great success. Jon asked if a replacement part warrantee restarts once replaced. Mark did not know the answer and said he would look into it.

23-79 Board of Selectmen Comments

Toby Pond asked why Fayette cannot duplicate what the Town of Wayne does for its residents, strawberry festival, farmers market every week and bake sales, fishing derby and the other is related to costs of swimming at the Readfield Beach. Brent St Clair shared that he thought trading the East Road property for the Stevens property by the Country Store would be a good idea toward creating something like Wayne. Michael Carlson shared that 32% of residents have presubscribed. Mike reviewed recent correspondence from Matrix. Lacy reminded everyone there is a casserole supper at Starling Hall on July 22, 2023. Mike volunteered to write a letter to the public to encourage them to presubscribe.

Brian Holman asked to make a move to tear down the building on Campground Road. Brian made a motion to start the process of cleaning up the 700 Campground Road property by November 1, 2023 seconded by Jon Beekman vote 5 in favor and 0 opposed.

Lacy informed the Board that she visited the Underwood Memorial Library and was impressed with the operation. Lacy also relayed that the Animal Control Officer requested the Town consider a livestock trailer be considered. Toby read at the Library and asked what we can do to get air conditioning in the library. Toby what do we have for authority over that. Mark responded that it is a Town building.
