#### 23-66 Board of Selectmen Comments

Michael Carlson referenced that Jon Beekman's e-mail regarding the County asking for FOIA certifications only applied to Jon and not the rest of the Board. Lacy mentioned she was asked if the Town could spray insecticide to kill ticks. A lengthy discussion ensued including brown tail moth expansion. Mark mentioned that the Town is not addressing the tick or moth matter in Fayette. Michael Carlson expressed his concern about Norm Currier and a truck. Toby expressed concerns over numerous ticks on KLT trails. Toby expressed concern over the Road Foreman mowing the side of the road when we have part-time people to do that. His time could be better served. Toby's culverts. Michael Carlson reminded Mark about discussing Starling Hall. Mark stated whereas the Hall is now being requested by outside groups our insurer has requested that the Town facilitates each event and group enter in the Tenant User Liability Insurance Program. Mark asked the Board to authorize him to schedule the groups with the understanding they acquire the TULIP insurance ryder. Brian Holman mentioned that he knew of someone that could bushhog and chip trails on the East Road property.
